Non - Profit of the Year - Nominee must set a consistent example of dedication to providing goods and services that "improve quality of life" in the community.

Green Business Award - Highlights a business that has earned the California Green Business Network Stanislaus certification. They continue to evolve in ways to sustain environmentally friendly business practices.

Small Business of the Year Award - (Awarded to a Company with 25 or fewer on staff) Nominee must show innovation in business practice, have a superior customer service philosophy, and must show overall growth as a company.

COVID Resilience Award - Awarded to a business who has shown exceptional resilience in response to the impact of COVID19. This Business made innovated adjustments to sustain their business, support their employees and be a resource to the business community.

Chamber Member of the Year Award- (Awarded to a Company)
Nominee has shown a continued commitment to promoting the business community's growth through their investment of time, resources, and personnel, supporting the Chamber's Mission of business growth.

Distinguished Service Award - (For an Individual) Nominee has displayed exceptional dedication in furthering the mission of the Modesto Chamber of Commerce and enhancing the Chamber's programs and services.

THE FOLLOWING ARE PEER AWARDS, NOMINATED AND VOTED ON BY THE PARTICIPANTS OF THAT GIVEN PROGRAM.

Welcome Team Member of the Year Award - This award recipient has displayed exceptional dedication in furthering the mission of the Chamber through participation on the Welcome Team. The Nominee has been a regular participant in welcoming new members to the Chamber and volunteers at Chamber Events.

Excellence in Education Award - The recipient of the Excellence in Education Award recognizes a local program, project, event, or individual that displays the following criteria: is visionary/forward looking, demonstrates advancement of the community's economic well-being by preparing the future workforce with up-to-date skills and good work habits, and shows significant evidence of cooperation between the recipient and one or more members within the community.

Citizen of The Year Award - (For an Individual) This is chosen by nominations made and voted on from within the Modesto Chamber of Commerce Board of directors.

In choosing who you wish to nominate:

- **Businesses must be members of the Modesto Chamber of Commerce for at least one full year.**
- **A description of why your nominee deserves that award is REQUIRED with your recommendation.**
